### At a Glance Vendor Conduct Rules and Regulations

- Vendors must provide their own canopies, 10lbs weights for each leg, tables, chairs, tie-downs and other equipment. Staking of tents is not permitted. Note: The event does NOT provide electricity, wifi or supplies.
- The Vendor Committee reserves the right to refuse and prohibit any products/service from being sold or distributed. The Event Director's actions and decisions are final.
- The Fife Community Car Show Committee, staff, volunteers, and partners are not responsible for any and all losses or damages of product or property associated with this event.

Event vendors will comply with the following conduct and responsibility requirements:

- Event vendors will ensure that they and their volunteers conduct themselves in a personable and businesslike manner with customers, event staff/volunteers, public and other vendors.
- All vendors will keep their vendor spaces clean and help to keep the premises clear of litter. If any vendor should, at any given time, present him/herself in a manner contrary to these rules and regulations, or in a hazardous or offensive manner to the public, other vendors, staff, volunteers, etc, will, upon request of event staff, immediately stop the offending conduct. Failure to immediately comply will be just cause for revoking a vendor's permit and his/her removal from the event. No refunds will be given.
- *Set up, Parking:* Event representatives will be on hand by 7:00 a.m. to guide vendors to the supply drop-off area(s) and vendor-only parking after supply drop-off. Vendors must complete their set-up by 8:30 a.m. and be ready to engage with community by 9:00 AM or earlier.

**Food Vendor- Food vendor space is limited and hence, we will be contacting food vendors directly.** In general, however, approved participating food vendors must have a current, valid food service permit issued by Tacoma-Pierce County Health Department and all required license and permits. All food vendors must register and receive a permit from Tacoma-Pierce County Health Department Information about obtaining a permit can be found online at: [www.tpchd.org](http://www.tpchd.org). Vendors must comply with local the Fire Code. **It is the responsibility of the vendor to obtain all required permits and licenses and to display them on the food vendor truck during the entirety of the event.**
